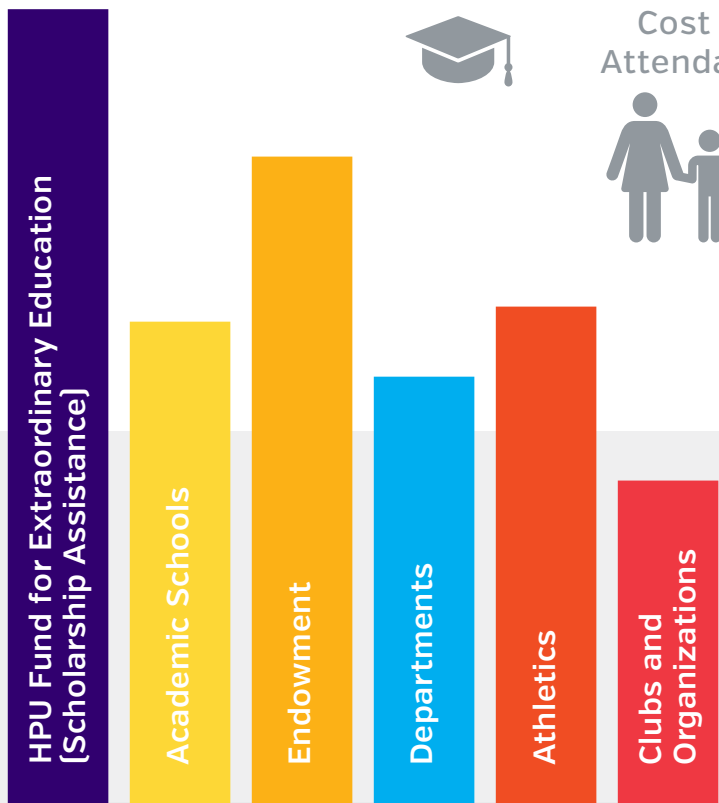
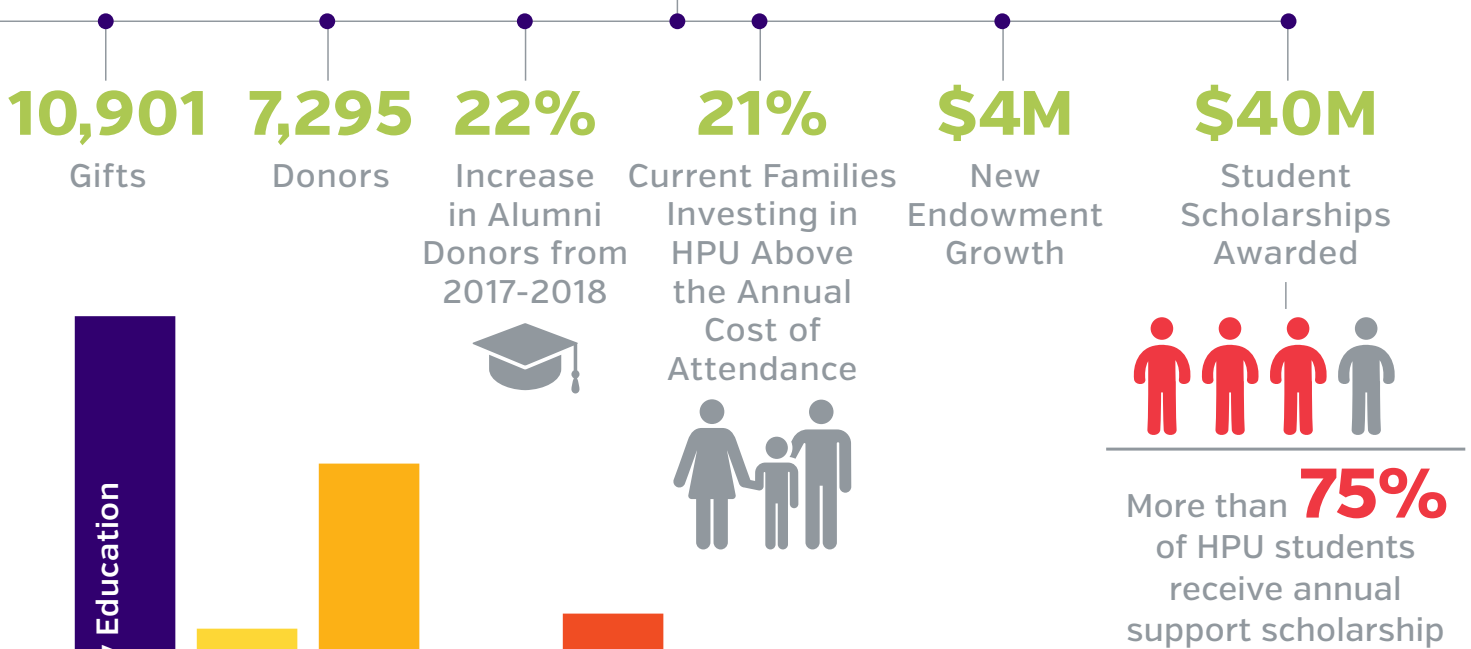

The Wanek School of Natural Sciences, a \$65 million, 128,000 square-foot facility, opened for classes this fall. The new building houses four stories of innovative learning spaces, the Culp Planetarium, and five different undergraduate programs in the natural sciences, including biology, chemistry, biochemistry, neurosciences and physics.

In September 2018, ground was broken on the 15,000 square-foot Caine Conservatory named for a long-time Triad family, Don and Teresa Caine. The Caines are avid supporters of High Point University and first established an endowed scholarship to support students who demonstrate academic merit and financial need. The Caine Conservatory will be located next to the Wanek School of Natural Sciences. It will provide a space for students and faculty to conduct botanical research and propagate plants for the Mariana H. Qubein Arboretum and Gardens.

GIVING THAT GROWS – ESTATE AND PLANNED GIVING

A letter or a phone call is often all it takes to include High Point University in your long-term planning. Your gift will help enrich the HPU experience of students, and remove assets from your taxable estate.

Additionally, those who choose to make a documented, planned gift to High Point University are eligible for membership in The Sterling Society.

A CODICIL TO YOUR WILL: Place HPU in your will without rewriting it. The University can confidentially provide your attorney with sample bequest language.

DESIGNATION OF RETIREMENT PLAN BALANCE: To give without disturbing your will at all, leave part or all of the remaining balance of your plan to HPU. Contact your plan's manager to make your chosen designation.

POD ACCOUNTS: HPU can greatly benefit from balances remaining in certain bank accounts at death. To make such a gift, complete a designation of beneficiary form at your bank.

LIFE INSURANCE: An old policy which remains in force, but has outlived its usefulness to you, can make a substantial gift at HPU and provide a current tax deduction. In addition, many people enjoy group term life coverage as an employment benefit. Your insurance agent can help you make HPU both policy owner and beneficiary.

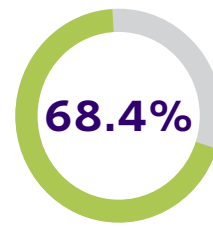

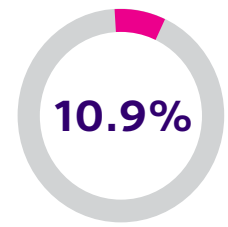


HPU ENDOWMENT FUNDS
